Delta employment levels takeoff in June

Atlanta Business Chronicle

[Delta Air Lines Inc.](#) had a big jump in year-over-year employment in June, according to the [latest figures](#) from the [Department of Transportation](#)'s Bureau of Transportation Service.

The Atlanta-based carrier reported 68 percent more employees, growing to 75,600 full-time equivalent (FTE) workers from a staff of 45,600 in 2009.

Those figures reflect the merger of Delta (NYSE: DAL) and Northwest Airlines. Delta still reported 5.9 percent more FTEs in June 2010 than the combined totals of both carriers for June 2009.

Delta employs more FTEs than any other carrier.

[AirTran Airways](#) (NYSE: AAI), which hubs at [Hartsfield-Jackson Atlanta International Airport](#), had an employment drop of 1.4 percent to 8,083 FTEs in June.

Overall, U.S. passenger airlines employed 2.4 percent fewer workers in June 2010 than in June 2009, representing the 24th consecutive decrease in FTE levels for carriers from the same month of the previous year.

Delta Air flight attendants closer to union vote

Federal labor board takes another step toward flight attendant union vote at Delta Air Lines

MINNEAPOLIS (AP) -- A federal agency has taken another step toward a union vote for flight attendants at Delta Air Lines Inc.

Flight attendants who worked for Delta before it absorbed Northwest were nonunion. Their colleagues who came from Northwest are unionized. Delta bought Northwest in late 2008.

The National Mediation Board ruled on Monday that the two are operating as a single carrier. Flight attendants will trigger a union election if the Association of Flight Attendants-CWA can show interest from at least 35 percent of them. Delta has about 20,000 flight attendants, including more than 7,000 who came from Northwest.

The union has two weeks to show enough interest for an election.

FAA set to propose penalty against American Airlines: report

NEW YORK (Reuters) - The Federal Aviation Administration is set to propose a penalty against American Airlines of at least \$25 million for maintenance lapses that resulted in widespread flight cancellations in 2008, according to a report on the Wall Street Journal's website citing people familiar with the matter.

The fine could be nearly three times as large as any levied against a U.S. airline before, according to the Journal.

No final decision has been made but American Airlines, a unit of AMR Corp (NYSE:[AMR](#) - [News](#)), has been told to expect the action, the sources said.

The penalty stems from April 2008, when American Airlines was forced to ground its entire fleet of 300 McDonnell Douglas MD-80 jets due to technical problems with the landing gear, according to the Journal.

Comments - This message might well be titled, "The V.A. and Me."

Last spring during a routine checkup, I inquired of my general practitioner if he could get me a referral for a hearing test. He remembered that I was a veteran and advised me to speak with my local V.A. representative. I called and got an appointment with him. My representative has an office in the county court house. You will have to see where your nearest one is located. The rep conducted an interview, made a copy of my DD214, and helped me fill out some forms to get me into the system. He wanted to know if I had ever set foot in Viet Nam. I replied that I had flown Navy C-130's into and out of Viet Nam on several occasions. He thought the application would initially be denied because of "means testing," but then approved because the V.A. has determined that anyone who was ever on the ground in Viet Nam is presumed to have been exposed to Agent Orange. Paperwork was then submitted.

About three weeks later I received a letter and schedule for two appointments about four days apart in the last week of May. These were at my closest V.A. Outpatient Clinic. The first was for lab work with fasting, and the second was to discuss the results. After driving 25 miles for the first appointment and checking in, I was told the appointments had been cancelled (see Agent Orange statement above). I was not notified of the cancellation, just given a new set of appointments – a 50 mile round trip for nothing. The second round went better. I had a 3 page blood work-up done and gone over by a nurse on day two. I had an ID photo taken and received a V.A. identification card mailed to me. I mentioned a hearing test and once again received an appointment by mail for about four weeks later at the main V.A. facility near me. This was done last week, and I found I was qualified to receive a hearing aid(s) and told I would be notified when they came in. They would then schedule a fitting. I was also given a booklet for the first time explaining some of the illnesses covered under Agent Orange exposure, prostate cancer being one of those listed.

Upshot of this tale is – if you have plenty of time to spare, this might be something worth looking into. At least, in my case, I got a free physical, a nifty I.D. card and free hearing aids. As emphasized above, you MUST have set foot in Viet Nam. The Viet Nam service medal referenced on the DD-214 may not count. Further proof may be required, such as a set of orders, or in my case, flight log entries. So far, I have not been asked for any further proof. Please excuse my ramblings, I'm old. No guarantee as to the accuracy of the above is given or implied. Good luck!

The EAL Capt, Dick Merrill, who flies right seat for Arthur, was very well known around MIA back then. This was cutting edge at that time.
